### Introduction

Clackamas Women's Services (CWS) is one of the most comprehensive nonprofits in Oregon dedicated to issues of domestic and sexual violence, including prevention, intervention, and recovery. We provide wrap-around supports for survivors driven by a whole-person and whole-family approach, and participants are recognized unconditionally as experts in their own self-determination.

CWS services are accessible at our Shelter and Housing Program, A Safe Place Family Justice Center (ASP-FJC), Clackamas County DHS offices and Behavioral Health, and in rural communities through our mobile advocates and Promotoras Program. We are a lead service provider at ASP-FJC, which is a safe location where advocates, service providers, legal professionals, and law enforcement collaborate under one roof to help survivors report a crime, plan for their safety, obtain help with protective orders, receive counseling, and receive information on shelter, medical care, and other vital resources.

Cross-sector partnerships ensure our services are culturally responsive, linguistically specific, and accessible to those most impacted by oppression and violence. Leveraging cooperative agreements and coordinated efforts enable CWS to enhance critical supports for survivors from all backgrounds.

CWS Leadership Team has extensive experience in the fields of domestic violence, gender equity, social justice, organizational development, public policy, and trauma-informed care.

We have openings on our Board of Directors, and we seek Board members who reflect our community. The most important qualifications are a desire for social change, an eagerness for heart-centered leadership, a commitment to healthy collaborative work and enthusiasm for supporting our staff to do our best work. Our work sits at many intersections, and we believe many people have a skill, interest, experience, or attribute to help further our mission. We welcome the opportunity to learn more about how we can work together.

## **Participant Highlight**

Sierra came to CWS as a 13-year-old when her mother was facing a difficult personal situation involving threats. Sierra had counseling at other places, but it hadn't worked for her. Then she met counselor and Camp HOPE Program Director Cat Koch. Sierra was hesitant about attending camp, but after her first counseling session with Cat, she was excited to dive in. In Sierra's words, "I immediately connected with Cat. She didn't look at me as a victim. She helped me understand that I'd had a bad chapter in my life but that it didn't mean it



should hold me back from doing great things. We still have a wonderful bond."

After three years as a Camp HOPE Oregon participant, Sierra now volunteers as a camp counselor. She credits camp with helping her find strength and healing. "You learn you're not alone," Sierra shared. "You discover other people are going through the same things. I thought nobody knew what I was going through. That it was the worst thing to happen and it was happening to me. You make lasting friends. Camp HOPE -the name is right on the nose. It's a perfect name!"

# Our Impact in 2021

- We provided more than 8,000 nights of safe shelter to 170 adults and 133 youth in our emergency shelter, with about half identifying as BIPOC.
- We received nearly 3,000 calls on our 24-hour Crisis and Support Line; 297 text/chat conversations were received on our confidential Text and Chat Line.
- 1,826 survivors accessed our community-based services.
- 4,757 elementary, middle school, and high school students received virtual or in-person domestic violence prevention lessons through 748 presentations in 19 Clackamas County schools.
- 47 youth attended Camp HOPE America Oregon; 64 youth attended community-building Pathways Program events.
- 533 counseling sessions were provided to adults and youth via Telehealth.

### About Clackamas Women's Services

In 1985, neighbors opened homes and shared what they had to build a safer community for families – the beginning of Clackamas Women's Services (CWS). Our services have grown beyond shelter, and we offer a wide range of resources to anyone experiencing domestic and sexual violence, from initial crisis to long-term healing. We work with community members, other social service agencies, and local businesses to build a community that supports and uplifts survivors of domestic and sexual violence.

Clackamas Women's Services helps individuals and families experiencing and healing from domestic and sexual violence, child and elder abuse, stalking, dating violence, and trafficking. We work with survivors currently experiencing violence to plan for their safety, as well as help to heal from trauma in the past. Our programs and services are free, confidential, available in multiple languages, and with any accommodations needed. Our support is available regardless of gender identification, sexual orientation, age, and immigration status to ensure anyone escaping violence can access the resources they deserve. We honor the depth and diversity of lived experiences across our community.

Our mission is to break the isolation of domestic and sexual violence.

# **Programs and Services**



### **COMMUNITY-BASED ADVOCACY**

Advocacy and case management, including: emotional support, safety planning, help filing for protective orders, and help accessing community resources and navigating public systems. Services are available at A Safe Place Family Justice Center, Clackamas County DHS offices and Behavioral Health centers, and in rural communities via our mobile advocates and *Promotoras* Program.

#### **YOUTH SERVICES**

Confidential individual, family, and group support for children and youth who have experienced family, sexual, or dating violence.



### **LATINA SERVICES**

Culturally specific services for Latinx communities, along with leadership development opportunities for Latinx survivors and staff.



#### **COUNSELING AND SUPPORT GROUPS**

Individual counseling and a range of support groups, including youth and family counseling.



Training about how to prevent domestic, dating, and sexual violence, including school-based violence prevention programming for K-12 grade public school students.



#### 24-HOUR CRISIS AND SUPPORT LINE

Emotional support and safety planning for survivors. Consultation and support are also available for family, friends, and other service providers.

### SHELTER AND HOUSING

Connecting survivors with a supportive community and the space to rebuild their lives via emergency shelter, short and longer-term housing solutions, with ongoing case management and support.
